ST GERMANS PARISH COUNCIL

MINUTES OF THE MEETING OF ST GERMANS PARISH COUNCIL HELD ON MONDAY, 1ST SEPTEMBER 2025 AT POLBATHIC HALL STARTING AT 6.30PM.

1.. Chairman to open the meeting followed by the public session. The Chairman welcomed the member of the public and invited them to address the Council, if they so wished. Nigel Witton reported on the completion of the work to repair and repaint the metal railings in St Germans, a project he had started when he was a Councillor and managed throughout the duration of the work. The railings were 632 feet in length. The dog waste bin had been moved, and the general rubbish bin had been emptied and a new bag fitted inside. The Chairman thank Nigel for his work and expressed the councils appreciation to Cllr Hodge, Cormac and the contractor who carried out the work.

A question was raised about the asset transfer of St Germans Play Park to the Parish Council. Cllr Ewert offered to obtain an update from Cornwall Council.

It was noted that an adjacent property had made a gateway into the woodland area, and someone had burnt the remains of an ash tree.

Councillors also noted a bus had got stuck on the traffic island in St Germans when trying to negotiate the junctions.

Hydrogen sulphate had been seen coming out the drains in Treglister Gardens during recent heavy rain; and residents of one property flooded with sewage will need to vacate their home until repair work had been carried out.

- 2. Apologies for absence were accepted from Cllrs. P Chilton, B Skelton, S Barnes, R Elliott, T Hooper
- **3. Declarations of interest relating to matters on the agenda.** None declared at this stage of the meeting.
- **4.** To approve the minutes of the meeting held on Monday, 28 July 2025. The minutes of the meeting held on the 28th July 2025 were approved and signed by the Chairman following amendments to the grammar on Items 1 and 5. Proposed by Cllr True, seconded by Cllr Hodge and unanimoulsy agreed.
- **5. Report from Cornwall Councillor Kate Ewert.** Cllr Ewert notified Councillors of the quote to repair the damaged wall adjacent to St Germans Play Park. This had been accepted by Cormac and work should start within the next few weeks.

A planning enforcement case had been created for the operations going on at the Three Corner Field in St Germans. The local MP had been contacted by residents.

The Tunes in the Park at Port Eliot Estate was well organised overcoming the problems experienced with the Wild Gardens event organisers.

The Community Area Partnership (CAP) Highway Scheme would launch in the Autumn for minor highway works. Cllr Ewert had received a request for double yellow lines in areas of St Germans although this would restrict some parking in the village if implemented.

Residents of Tideford appeared happy with the reduced 30mph speed limit through the village. A consultation was being organised for a pedestrian controlled crossing for the village with the location yet to be confirmed.

- **6.** Three Corner field, St Germans work being carried out. Nothing further to report. Item discussed under Item 5 of this meeting.
- **7.** Burial Ground to receive an update on the burial ground and approve any work required. The Clerk and Cllr Elliott were monitoring the burial ground until Cllr Chilton was able to resume this duty.
- 8. Planning applications -to discuss and vote whether or not to approve:
 - a) PA25/05878 Leycott, Tideford Cross Proposed single storey rear extension. Support; proposed by Cllr Hodge, seconded by Cllr True and unanimoulsy agreed.

Planning Matters – to note any planning matters requiring attention. Nothing to report.

- 9. Cornwall Council Planning decisions and reports to be noted:
 - a) PA25/03903 North Wall Farm, Tideford Crosss Proposed enlargement of existing access to allow for vehicular access and additional parking. Approved.

10. Finance

- i) to note and approve current financial position on all accounts. The bank reconciliation was noted and bank balances checked by the Chairman.
- **ii) to approve and authorise the payment of accounts, as circulated.** Councillors unanimoulsy agreed the accounts be paid; proposed by Cllr Hodge, seconded by Cllr True. The Clerk notified the council of the delayed salary payment owing to Tamar Accounting moving their payroll work to another office following David's retirement. This was discussed and the Chairman offered to speak to the company, if needed.

Cllr True had received copies of parish council paperwork from the family of a late Councillor. It was established this was only Councillor copies and they could be destroyed. Cllr True to action.

- **15** Nut Tree to nominate a Councillor to write a report for the next parish magazine. The Clerk will submit the report for the October edition.
- **16.** Parish Council Policies Review of the parish councils Grants Policy and Complaints Policy Clerk and Cllr Hodge. Review completed with no recommended changes. **Freedom of Information Policy** Cllr True had amended the policy and will circulate to Councillors. Approved.
- 17. Playparks and public areas:- to identify and approve any work requiring attention.
- i) **St Germans / Treland.** No issues to report. The Clerk notified the meeting that the Tree Consultancy Company were visiting the park today. The report will be circulated, once received.
- **ii) Tideford.** Cllr Hodge reported a loose bolt on the slide had been tightened. Costs are being obtained to carry out maintenance work to the log walk. Trees on the boundary hedge needed to be trimmed. The Clerk will speak to the contractor.
